Public Meeting to Open Sealed Bids**


(Minutes of November 30, 2021 Meeting)



MEMORANDUM OF UNDERSTANDING

This agreement is by and between the following parties:

ASCENSION PARISH CLERK OF COURT, ("Clerk"), represented herein by its Clerk of Court, Bridget Hanna, and;

ASCENSION PARISH ASSESSOR'S OFFICE, ("Assessor"), represented herein by its Assessor, M.J. "Mert" Smiley, Jr.

1. PURPOSE

The purpose of this Agreement is to transfer ownership of certain assets from the Assessor to the Clerk.

2. SURPLUS PROPERTY DECLARATION AND LOCAL SERVICES LAW

Assessor declares the assets being more particularly described as Larson Metal Roller Shelves (Tag 6 808) are deemed surplus property. Said Larson Metal Roller Shelves were acquired on November 7, 2001, are fully depreciated, and have no book value. Assessor further intends to sell said surplus property to Clerk by this Agreement in accordance with R.S. 33:1321 et seq., the "Local Services Law." The "Local Services Law" provides for the purchase of surplus materials and supplies by one public entity from another without the requirement of a public auction as specifically indicated in La. R.S. 38:2212.1(D). The price paid may be in money or in services.

3. OBLIGATIONS OF THE PARTIES

- a. Assessor declares that for and in consideration of the cost to remove the Larson Metal Roller Shelves at a price and sum of **Three Thousand Four Hundred Seventy-Five and 00/100 (\$3,475.00) DOLLARS**, which said payment shall be made by Clerk to the moving company as a service to the Assessor, Assessor hereby sells and delivers with full warranty of title and subrogation to all rights and actions of warranty Assessor may have, unto Clerk the assets being more particularly described as Larson Metal Roller Shelves.
- b. Clerk acknowledges and accepts possession and delivery of the assets being more particularly described Larson Metal Roller Shelves.

4. LEGAL CAPACITY

All parties signing the within instrument have declared themselves to be of full legal capacity, and all agreements and stipulations herein, and all obligations herein assumed shall inure to the benefit of and be binding upon the heirs, successors, and assigns of the respective parties, and the Assessor, its heirs and assigns shall have and hold the described property in full ownership. This written Agreement shall constitute the entire Agreement between the parties.

5. SEVERABILITY

In the event any section, subsection, sentence, clause, phrase or word of this Agreement shall be and is for any reason held or declared to be void or unenforceable, all the remaining provisions of this Agreement shall be fully effective and shall not be affected by the void or unenforceable section, subsection, sentence, clause, phrase or word.
